As you may be aware, currently there are a group of people in Mosney Direct Provision Centre, selected for transfer out of the centre and who are refusing to move.

My office has been contacted today by the Department of Justice, Equality and Law Reform in relation to a general query, as to whether the SWA payments would cease should a letter issue from DJELR to state that these persons are no longer entitled to Direct Provision in Mosney.

My decision is that should such communication arrive we would have to have confirmation from Department of Social Protection (SWA Section), before we could stop these payments. Until this has been clarified by DSP, these payments will continue as normal.

Communications to my office from DJELR in relation to this query would indicate to me that they are unhappy with my stance as outlined.

Re: SWA Payments to residents in Mosney subject to transfer - LMCM3674

Dear Noel,

In relation to the matter above, our Office has received a verbal request as to what Meath Community Welfare Services opinion might be, to stopping SWA Payments for those persons above should a letter issue from the Department of Justice, Equality and Law Reform to state that they no longer qualify for Direct Provision in Mosney.

Our Liaison Officer for Asylum Support Services, Mr Michael Smith's Office, advised both Linda Keating and Steve Magnier of DJELR, that should such a communication arrive to us, we would have to have confirmation of approval from the Department of Social Protection (SWA Section), before we could stop these payments. Until this has been clarified by DSP, these payments will continue as long as the above people remain resident in Mosney.

If a more formal communication, on the subject, is to issue we will address it in the above manner.

Please also be aware that in previous discussions with the DSP (SWA Section), regarding a similar situation, SWA Section expressed their reluctance to cease payments in cases like this.
